Call to Artists

Opening reception and awards presentation: May 16, 2006, 5 to 7PM.

Art Center Hours: Tuesday through Sunday 10 AM to 4PM

Deadline for submissions: May 9, 2006

Awards: Exemplary works will be awarded the following prizes in the categories of black and white and color photography: First Place \$500; Second Place \$300; Third Place: \$100; (3) Merit Awards \$50 gift certificate.

Juror: Nancy Hellebrand, Photographer. Nancy Hellebrand's solo shows include the National Portrait Gallery in London; Pace/MacGill, New York; the Morris Gallery at the Pennsylvania Academy of Fine Arts and the Paul Cava Gallery in Philadelphia. Her photographs have been included in Major group exhibitions organized by the Museum of Modern Art, the International Center for and the Philadelphia Museum of Art. Hellebrand's works are in the permanent collections of the Museum of Modern Art, New York, the National Portrait Gallery in London, the Art Museum, Princeton University, and the Philadelphia Museum of Art.

Submission Guidelines: All art submitted must be the original work of the applicant, and completed between 2003 and 2006. Entries must originate from a photograph and may not incorporate elements produced by anyone other than the artist.

Receiving: In person deliveries must be received May 9, 2006 10 AM – 3PM. Parcel Service must be received at the Art Center by May 8. Art Center Sarasota: 707 North Tamiami Trail, Sarasota, FL 34236.

Return of work: Pick-up at the Art Center Sarasota, June 18, 2006 10AM – 3PM
Return of work received through parcel service: Use re-useable shipping cartons and packing material. Artwork will be pre-packaged and returned in the same manner as received. Return address must be an actual street address. NO POST OFFICE BOX ADDRESSES. When shipping please include instructions and payment for returning work (Federal Express, UPS, etc.) ALL SHIPMENTS MUST BE SENT PRE-PAID OR THEY WILL NOT BE ACCEPTED. NO C.O.DS WILL BE ACCEPTED.

Artists may submit up to 3 images

Entry Fees: \$15 for the first entry, \$10 for the second entry, and \$5 for each third entry. Checks payable to Art Center Sarasota

Mounting: Mount using white or off white mount or foam board.

NO FRONT MOUNTING AND NO FRAMED ENTRIES. Boards must be 16 x 20 in.

Size: Works must not exceed mount board size of 16 x 20 in.

Entry Form: For Parcel shipped entries please complete two copies of the entry form on page 2 for each entry. Attach one copy to back of mount, upper right corner. Include second copy with your entry fee.
